Location: **Georgetown University Law Center, Bernard P. McDonough Hall, Hart Auditorium, 600 New Jersey Ave. NW, Washington, DC 20001**

**(Public Entrance on 600 New Jersey Avenue at the top of the stairs, between G & F St. NW)**

**Registration will take place in the lobby of the Hart Auditorium of McDonough Hall.**

When you enter McDonough building at the New Jersey entrance lobby, take elevators on your right or winding staircase on your left down to first floor, this should bring to registration area.

- *Be prepared to show a photo ID to enter into the building.*
- *Backpacks and larger bags will not be allowed in the conference area during the morning session.*
- *You may be subject to security screening and search when entering the conference.*

**Directions by Metro:** The Law Center is easily accessible by Metro. Take the Red Line to Union Station and exit onto Massachusetts Avenue. Turn right on Massachusetts Avenue and walk to the corner of Massachusetts Avenue North Capitol and F Street. Cross Massachusetts Avenue, turning left onto North Capitol Street, and then turn right onto F Street NW. Walk 1 block to the intersection of New Jersey Avenue, F Street, and First Street. Cross over and turn right onto New Jersey/First Street NW. The entrance to Bernard P. McDonough Hall is at the top of the stairs at 600 New Jersey Avenue, between F and G Streets. Accessible entrances are at the side doors on G and F Streets, however these doors may not be immediately open.

**Directions for TAXI:** We suggest taking a taxi to **600 New Jersey Avenue, NW, Washington, DC**. The entrance to Bernard P. McDonough Hall is at the top of the stairs at 600 New Jersey Avenue, between F and G Streets. Accessible entrances are at the side doors on G and F Streets, however these doors may not be immediately open.

**P** **Parking:** Parking is very limited around the Law Center. There is limited metered street parking available, along with some parking garages around the Law Center. *Availability is not guaranteed.* There is a parking garage across the street at 601 New Jersey Avenue, NW (MarcPark, Inc.), entrance on an alley F street (approx. address 85 F street- across the street from AFT entrance-). Early bird price before 9:30am is \$17 per day. There is another Colonial public parking garage entrance on E street next to the Hotel George (located in alley at approx. address 21 E street). Cost is \$21 per day.
